



## St. John's University CRS Global Campus: Faculty Global Microresearch Grants Fall 2023–Spring 2024

**Purpose:** The Catholic Relief Services (CRS)' Global Campus grants are intended to support St. John's University's faculty who pursue new and ongoing mission-driven global research. This program facilitates faculty participation in the global mission of the University and the application of faculty expertise to St. John's as a CRS Global Campus.

We are soliciting applications for Fall 2023–Spring 2024 projects. Applications are being accepted on a rolling basis, with additional grants awarded as funding permits. For Summer 2023 projects, please submit your application by May 30. For Fall 2023/Spring 2024 projects, applications will be accepted until September 15.

We seek applications to support a wide range of global topics connected to promoting sustainable development, responding to emergencies, fighting disease and poverty, and nurturing peaceful and just societies. The focus of the project must be global in nature.

### Eligibility:

\*All Full-time tenured and tenure-track faculty across the University may submit applications for **\$500** to support an acceptable project during the 2023–24 academic year (i.e., July 1, 2023–May 30, 2024). **This grant is for reimbursement of Concur-able expenses only, and not for a stipend or gifts.**

\*This grant may be used to support fieldwork, archives research, other academic research in the field, or for preparatory training such as language courses or new method or technology training necessary to begin a new project. It may be used for conference participation. Faculty are not eligible to receive this grant in two consecutive years.
