Established in 1995, the "Insurance Leader of the Year Award" has annually recognized the contributions of outstanding individuals whose leadership in the worldwide insurance and financial services industry set them apart from their peers. On the occasion of the Award's 25th Anniversary an Insurance Leader "Lifetime Leadership" Award was bestowed upon Maurice R. Greenberg, Chairman and Chief Executive Officer of C. V. Starr & Co., Inc.

The Maurice R. Greenberg School of Risk Management, Insurance and Actuarial Science was founded in 1901 as the Insurance Society of New York and over the years evolved into The College of Insurance (TCI). In June of 2001, TCI merged with St. John's University, becoming the School of Risk Management, Insurance and Actuarial Science, part of The Peter J. Tobin College of Business. On the occasion of celebrating Mr. Greenberg's "Lifetime Leadership" Award in January 2020, it was announced that the University Board of Trustees had voted to rename the School in his honor, effective immediately.

St. John's University awards undergraduate, M.B.A., and M.S. degrees in insurance, risk management, and actuarial science disciplines. Through the Tobin College's Center for Executive Education, the University also provides education, training, and consulting services to industry, governments, and regulators worldwide. Greenberg is a global leader in risk and insurance education and training and draws candidates from many regions of the world. All of the degree programs offered by the Tobin College of Business, and thus by Greenberg, are fully accredited by the Association to Advance Collegiate Schools of Business.



## M. Steven DeCarlo

M. Steven DeCarlo serves as executive chair of Amwins Group, Inc. Previously, he served as chief executive officer of Amwins for 17 years, leading the business through the merger of several specialty wholesalers. He has served on the Amwins Board of Directors since he joined the company in December 2000.

Steve began his career with Crum & Forster and later joined The London Agency (today part of Chubb) as its chief financial officer. DeCarlo was a founding partner of Royal Specialty Underwriting (RSUI), serving as executive vice president and chief financial officer, later becoming senior vice president of what was then RSUI's parent company, Royal & SunAlliance USA.

Steve remains active in the insurance industry, while continuing to serve on a number of business and charitable boards.

He was inducted into *Insurance Business America* magazine's Hall of Fame and was a Gala Honoree of the Spencer Foundation of NY. The National Insurance Industry Council recognized Steve as its Spirit of Life honoree for his efforts to raise money for the City of Hope to support research for treating life-threatening diseases. Most recently, he was honored during the 29th Annual Ronald McDonald House New York Gala and earned an Icon Leadership Award at Georgia State University's Riskies Awards.

A 1980 East Tennessee State University graduate with a bachelor's degree in accounting, he serves as a member of his alma mater's Board of Trustees.

Steve and his wife, Lee Ann, reside in Charlotte, N.C., and are the parents of three children, Jenna, Nick, and Reid. Steve and Lee Ann are also proud grandparents of their grandson, Jack.
